Location

Stone Trading Estate is located just half a mile to the east of Brixton town centre and benefits from great access to the A2217 Coldharbour Lane and the A23 road networks. The estate is well connected by public transport with two train stations in close proximity; Loughborough Junction and Herne Hill. Brixton Underground Station also provides direct access via the Victoria Line to Central London and there are numerous bus routes servicing the local area.

Description

An extremely rare opportunity to occupy up to 2,414 sq ft of modern industrial warehousing within a highly attractive Brixton location. Unit 14 and 15 are ready to occupy now, with Unit 16 available in December 2022. The units, which provide c3.45m internal clear height, contain a recently installed sheet metal roof alongside well-maintained cladding to the exterior elevations. The units will be refurbished prior to occupation with newly painted concrete flooring and walls. Occupiers also benefit from 24 hour access. Each unit has its own forecourt parking space as well as a spacious shared loading area which is well managed. All main services are in situ (gas/water/3 phase power). If required, the units can be split to provide three separate units.
