Location

The site is located on Selsdon Goods Yard in South Croydon. The site runs parallel to Purley Way which links Beddington to the M23/M25 intersection. Within the site, neighbouring tenants include Buildbase and Mact Scaffolding.

The City of London and West End are within 10.6 miles of the site with the M25 accessible within a 25 minute drive. The nearest train station is South Croydon on the Southern Railway.

Description

Both plots are largely level and fully hard surfaced secured via palisade fencing and manual gates. Both sites are fully serviced with power and water. While the plots are currently split into two separate plots, there is potential to lease both plots as one. Ancillary warehouse / portacabin accommodation is available on both sites and occupiers will be required to take the accommodation in its current state.

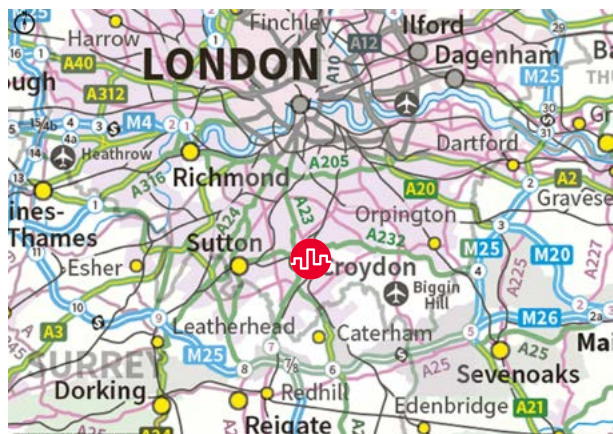
