Situated on Ossory Road, SE1 the Bottle Factory sits just off the Old Kent Road which connects Queen Road in Peckham with both Elephant and Castle and London Bridge. The space offers occupiers direct access to Central London via the A2.

The building has been modernised throughout and has been brought to life to host a number of SME's and local businesses for tenants.

Units 8 and 9 offer 1st floor class E units, suitable for a variety of office and alternative users. The 1st floor has been carefully refurbished to provide modern facilities, such as new WCs, showers, a Kitchenette, and LED lighting, while also retaining its character and distinctive industrial/warehouse-style feel.
